Yuanta Financial Holding Company Independence Criteria for Independent Directors

In order to improve the operational efficiency and duly execute the oversight function of the board and conduct its oversight function to secure public interest, the Company has set four independent directors in place in adherence to Corporate Governance Guidelines. Independent directors shall possess professional knowledge and maintain independence in executing their duties, and shall not have a direct or indirect stakeholder relationship with the Company. The independent directors of the Company not only have to meet the qualification requirements as stipulated in Article 3 of *Regulations Governing Appointment of Independent Directors and Compliance Matters for Public Companies* but are also examined against DJSI criteria for determining independence as an additional reference.

Each independent director's status in relation to DJSI's independence criteria is summarized in the table below:
